Minutes

Previous minutes and actions

All actions were completed in the previous period and minutes agreed.

Digitalisation Strategy and Action Plan release

In the previous period a first version Data Governance document was produced and disseminated throughout the business for review and comment.

A progress update on the Data Governance document was provided, where it's focus is on Technology, Process and People. It has been reviewed by a wide internal audience and a next updated version is to be completed by mid-February.

Wider discussion focussed on the Data Governance Maturity Model and that it would benefit from further review to assess WPD's 'as is' and 'to be' position.

The implementation of formal Data Governance within the business was discussed and how this would be effectively communicated internally.





CKAN - Connected Data Site

Overview provided on the development and implementation of the Connected Data site, which will act as an online Data Catalogue to provide customers, stakeholders and third parties a central repository for WPD that is described using a standard metadata approach and is searchable and discoverable.

This is planned for Beta release in mid-February.

Application Programming Interfaces

A proof of conecept has been initiated with IBM to trial a standardised API gateway as a mechanism to ingest third party and thrird parties to extract salient data from within WPD systems.

Integrated Network Model

Overview provided on the progress of the INM in the four regions. The initial delivery for the four regions is nearing completion and providing valuable information as to where master system data improvement should focus as well as facilitating common information model (CIM) files. The current data matching quality is good in general, however, there are significant gaps in the master data to inform INM that must be resolved through a process of master data improvement being undertaken by the D&D team.

There is a next phase required for INM to provide further data matching and investigation of asset and connectivity information, to be clarified as this current INM phase completes.

Wider discussion took place around the quality of asset data improving due to improved capture processes.

11kV Planner Tool

The 11kV PT activity is continuing, with Siemens currently developing the process to automate the network models from the CIM files generated through the INM. The next phase will focus on the supplementary data required to provide planners a full view of the network for analysis.

The solution is still on target for release in April.

Data Catalogue

The full tender has now been released for successful submitters in the first phase of the process. Prioritised internal datasets are being identified to be utilised within the first implementation of the Data Catalogue, planned for June following the final steps of the tender process expected to be April.
