

## **Conserving Load Diversity in Load Managed Areas**

Historically, diversity of the switching times for off-peak heating loads has been encouraged by the use of multiple "Standard Settlement Configurations" (SSC). Many of these SSCs are controlled using the Radio-Teleswitch System (RTS). RTS is now a legacy system and will soon become unavailable, possibly as early as 01/04/2021.

An uncontrolled move away from RTS has the potential to cause problems in locations such as the Scilly Isles, particularly when the network is running in "Island Mode" and not connected to the mainland. The risk is that many consumers all end up with new metering systems programmed to switch heating on at the same moment, resulting in load building up faster than the local generators can react to accommodate this.

Properties that are likely to contribute towards this problem are to be identified by assigning special "Line Loss Factor Codes" (LLFCs) to their details held in the National Databases. These LLFCs will alert Electricity Suppliers that any automatic load switching carried out by replacement metering equipment must be programmed by reference to the following table;
